121st Air Refueling Wing Welcomes \$6.4 Million Addition. A ribbon cutting ceremony for a \$6.4 million Security Forces/Weather Flight facility will be held on April 17, 2010 at 11 a.m. at the 121st Air Refueling Wing, Rickenbacker Air National Guard Base. "The new facility will provide much needed space for the Security Forces and Weather Flight Airmen," 121st ARW Commander Brigadier General Tom Botchie said. "The space will greatly expand both these squadrons' mission capabilities." The 21,137 sq. ft. facility will be home to the 121st Security Forces Squadron and the 164th Weather Flight. The building will include a weapons vault, state of the art central security control room, administrative space, Guardsmen training areas, computer training and testing areas, a weapons cleaning and maintenance room, a Fire Arms Training System room and a mobility equipment area. As the future home of the 164th Weather Flight, the building will include administrative offices, a weather observation area and a mobility storage room.

The second phase of this project is the renovation of Building 875. This area will be renovated to house the 121st ARW recruiting and retention office and the environmental management section. This phase is scheduled to be completed July 1, 2010. "The project will allow for geographically separated offices to be more centrally located allowing for a more cohesive campus feel," Botchie said.

VFW: Protect Vets from Health Care Penalty Thursday Apr 15, 2010. While the head of the nation's largest organization for combat veterans is pleased that Congress stepped in to assure Tricare beneficiaries that the new health care reform law will not penalize them for having military group health coverage, he says lawmakers need to do the same for veterans. On Monday, Congress gave final approval to the Tricare Assurance Act, which officially exempts Tricare beneficiaries from a health care reform requirement to purchase private health care insurance or face a \$750 annual penalty. The exemption results from declaring that Tricare, as well as health care coverage provided to nonappropriated fund employees of the Defense Department, qualify as minimal essential coverage under the new law.

Thomas Tradewell Sr., national commander of Veterans of Foreign Wars, is urging lawmakers to also send the White House a Senate-passed bill, S 3162, that provides the same exemption for all veterans' health care programs. The bipartisan Senate bill provides specific protection for some dependents' health coverage provided by the Veterans Affairs Department that is not explicitly

mentioned as essential coverage in the health reform law, formally known as the Patient Protection and Affordable Care Act. Two key House Members— Steve Buyer of Indiana and Howard "Buck" McKeon of California — have called for legislation that specifically protects people using military and veterans health care from being directly or indirectly harmed by health reform, but such provisions were omitted from the final legislation that was signed into law. Tradewell said there is still a chance to act if the House takes up the Senate-passed bill. "There are a few more parts to this mission, which won't be complete until the House passes S. 3162 and the president signs both bills," he said.

"National health care will help many veterans who are ineligible for DoD or VA care, but missing from the original legislation was language that specifically recognized all military Tricare and VA programs as meeting minimum essential coverage standards," said Tradewell, a combat-wounded Vietnam veteran from Sussex, Wis. "That meant stand-alone legislation was required to protect all the health care programs provided by the nation's two largest federal departments."

There has been some resistance in the House to passing the Senate bill out concern that this exemption could open the floodgate to other attempts to modify or repeal parts of health care reform. Rep. Bob Filner, D-Calif., chairman of the House Veterans' Affairs Committee, said he is not convinced that veterans-specific legislation is needed to clarify anything in the health reform law. If there is any confusion, Filner said he believes an executive order from Veterans Affairs Secretary Eric Shinseki or Health and Human Services Secretary Kathleen Sebelius would be enough to define VA-provided care as good enough to avoid the requirement to buy private health insurance or be penalized. <a href="http://www.armytimes.com/news/2010/04/military\_vfw\_healthreform\_041410w/">http://www.armytimes.com/news/2010/04/military\_vfw\_healthreform\_041410w/</a>

Pentagon Officials say Green Efforts Paying Off. USA Today, Monday Apr 12, 2010. It's not just the troops' uniforms that are green: The military says its investments to conserve energy and water are beginning to pay off, with benefits for cost, national security and troop safety. The Army has cut water usage at its permanent bases and other facilities around the world by 31 percent since 2004, according to Pentagon data. The amount of energy used per square foot at Army facilities declined 10.4 percent during that same period. The data do not include the wars in Iraq and Afghanistan, where increased troop levels caused energy usage to rise, but the military currently has several green measures in place there. For example, the military has spent more than \$100 million on "spray foam" insulation for tents in Iraq and Afghanistan, cutting leakage of air conditioning by at least 50 percent. The energy savings usually recovers the investment within 90 days, he says. The military's green efforts will result in at least \$1.6 billion in savings through the projects' lifetime, says Joe Sikes, director of facilities energy at the Defense Department. <a href="http://www.armytimes.com/news/2010/04/gns">http://www.armytimes.com/news/2010/04/gns</a> military energy conservation 041210/

**Bill Would Give More Leeway on Claims Appeals**. Army Times, Tuesday Apr 13, 2010. A key senator is calling for changes in claims appeals procedures so that veterans would not be penalized if their service-connected disability prevents them from meeting deadlines for filing paperwork. Sen. Arlen Specter, D-Pa., who was the Senate Veterans' Affairs Committee chairman when he was a Republican, said the change is needed as a result of a December federal appeals court ruling

against a Korean War veteran suffering from paranoid schizophrenia whose appeal was denied after he filed it 15 days late. The bill was referred to the veterans' affairs committee for review. Specter continues to serve on the committee but is now the junior ranking Democrat after his party switch last year left him with no seniority. Specter's Fair Access to Veterans Benefits Act, which he introduced Monday, would require the U.S. Court of Appeals for Veterans' Claims to consider if a veteran's service-connected disability would have made it difficult or impossible to meet a deadline for filing an appeal.

Contractor Casualties in Afghanistan. A recent Congressional Research Analysis looked at the number of civilian contractors killed in Afghanistan in recent months. Of the 289 civilians killed since the war began more than eight years ago, 100 have died in just the last six months. That's a reflection of both growing violence and the importance of the civilians flooding into the country along with troops in response to President Obama's decision to boost the American presence in Afghanistan. The latest U.S. Department of Defense numbers show there are actually more civilian contractors on the ground in Afghanistan than there are soldiers. The Pentagon reported107,292 U.S.-hired civilian workers in Afghanistan as of February 2010, when there were about 78,000 soldiers. This is apparently the first time that contractors have exceeded soldiers by such a large margin. Using civilian contractors to haul food, prepare meals and act as bodyguards has likely kept the Pentagon's official casualty figures lower than they would have been in past conflicts, where contractors were not as heavily used.

Contractor casualties are largely invisible to the public. They are not reported in totals provided by the government. If they were, the death toll in Afghanistan would have surpassed 1,000 -- 848 soldiers, 289 civilian contractors -- from 2001 to 2009, The number of contractor dead are released only through the Labor Department, which keeps count as part of an insurance program for contractors known as the Defense Base Act. <a href="http://www.propublica.org/feature/contractor-deaths-accelerating-in-afghanistan-as-they-outnumber-soldiers">http://www.propublica.org/feature/contractor-deaths-accelerating-in-afghanistan-as-they-outnumber-soldiers</a>

### This Week in Guard History.

April 12, 1944: Naples, Italy — Second Lt. Ernest Childers, Company C, 180th Infantry, 45th Infantry Division, receives the Medal of Honor from Lt. Gen. Jacob L. Devers, the U.S. Army's deputy commander for the Mediterranean Theater. Childers, a Creek Indian, joined the Oklahoma National Guard in 1937, rising to the rank of first sergeant by the time the 180th landed in Sicily in July 1943. He earned a battlefield commission to second lieutenant during this campaign. He remained with his company when it landed at Anzio, Italy, on Sept. 13, 1943. His actions nine days later earned him the medal. He is the only Native American Guardsman to earn the nation's highest award for valor.

15 April 1946. Lt. Gen. George E. Stratemeyer, the commander of the Air Defense Command, wrote the Chief of the National Guard Bureau that "The mission of the air national security of the United States . . . has been assigned in large measure to the Air National Guard.

## This week in Ohio Guard History

17 April 1861: The 1st Regiment, Ohio Volunteer Infantry was mustered into Federal service, becoming the first Ohio regiment organized for the Civil War. The 1st Regiment was organized from independent militia companies around the state, including the Cleveland Grays, Lafayette Guards (Dayton), Mansfield Guards and Jackson Guards (Hamilton). The Regiment was mustered out October 14th, 1864. It was engaged in 24 battles and skirmishes, lost 527 men in action, and marched 2,500 miles.

11-17 April 1970. Two of the three astronauts on the aborted Apollo 13 moon landing mission were former Air Guard jet fighter pilots. Capt. Fred W. Haise, Jr. had served in Oklahoma's 185th Tactical Fighter Squadron (1957-1959) and Ohio's 164th Tactical Fighter Squadron (1959-1963). Capt. Russell L. Swigert had been a member of Massachusetts' 131st Fighter Interceptor Squadron (1957-1960) and Connecticut's 118th Fighter Interceptor Squadron (1960-1965). Both fliers had been accepted into the astronaut program in 1966.

18 April 1975. Ohio's 145th Air Refueling Squadron became the first Air Guard unit to acquire a jet tanker, the KC-135A. That development was triggered by a 1974 Defense Department decision to save money by transferring 128 older KC-135s to the Air Reserve Components.26

Grimes Gathering of B-25s Features Flying Tribute to Legendary Doolittle Raiders. Record number of B-25 bombers to descend upon Urbana for historic celebrations. From April 15-18, 2010, the snarl of radial engines will fill the skies over Ohio as Urbana's Grimes Field hosts the largest gathering of privately-owned airworthy B-25 Mitchell bombers since World War II. As part of the events honoring the 68th anniversary of the Doolittle Raid – including a reunion of surviving Doolittle Raiders at the National Museum of the United States Air Force (NMUSAF) – at least 20 B-25s will land at Grimes Field beginning April 15 for the "Grimes Gathering of B-25s." For the first two days of their visit, Thursday and Friday, the twin-engine bombers will stage out of Grimes Field while practicing formation flights, offering rides and standing on static display.

On Saturday morning, April 17, the bombers will depart for a flight to the NMUSAF, where they will take part in ceremonies honoring the surviving crewmen of the famed 1942 raid on Japan. "This gathering will really help put Grimes Field and the city of Urbana on the map," said Chris Patton, executive director of the Champaign Aviation Museum and one of the organizers of the event.
