From the State Family Program Director Lieutenant Colonel (LTC) Robert Bramlish

The Family Readiness Office is focusing this year on how to assist unit FRGs build strong programs throughout the year. We have proven as a family readiness program that we answer the call when needed for a unit deployment. Our challenge now is to find a meaningful way to engage our families in a unit FRG program on a quarterly basis regardless of mobilization status.

One way to do this is to focus on welcoming new members to the Ohio National Guard and to reach out to their families. How nice might it have been for Mrs. Bramlish (my mother) to get a call from another parent or spouse of a service member, to welcome her into the Guard family, offer her a chance to ask questions that might be on a parents mind when their child enlists into the military, and finally, offer her a few POC as resources should she have any questions? The answer is obvious, the parent in almost all cases appreciate the effort and would likely want to participate in the FRG. This contact starts with a service member filling out a

Privacy Act Statement (PAS) and identifying their loved one as a key adult contact. The PAS gives the FRG Leader the permission to contact a family member and include them in the unit FRG.

On the Army side, we are introducing a new process to start reaching these new Soldier families and our FACs will be working through unit FRG Leaders to get this done. Once a new Soldier enlists into the Ohio Army National Guard, his/her PAS will be forwarded to the unit FRG Leader even if the Soldier is still drilling with the Recruit Sustainment Program (RSP) prior to completing their basic training. Reserve Income Replacement Program

Did you know that the Department of Defense officially kicked off the Reserve Income Replacement Program (RIRP) on August 1st? The first payments under this program took effect in the September 1st paycheck of eligible members of the Reserves and National Guard.

The Reserve Income Replacement Program was developed to provide specific payments to eligible members of the National Guard and Reserve who are involuntarily serving on active duty (the term active duty includes full-time National Guard duty) and who are experiencing a monthly active duty income differential of more than \$50.00, as determined by the member's Service Secretary.

The RIRP can not exceed \$3,000 monthly but may be very beneficial for our Guardsmen and women who face a reduction in income upon being activated and mobilized. For more information on this financial subsidy program please visit: http://usmilitary.about.com/od/guardandreserve/a/rirp.ht

Family Care Plans

Family Care Plans should be completed by all single soldiers that are legally and financially responsible for dependents (children, medically fragile parents) or any dual military status couples. The Family Care Plan is the legal document that explains who will be caring for the dependents during mobilization. It is very important to have completed and updated annually. The completion of the Family Care Plan is the soldier and commanders responsibility. The FRG leadership team can assist and identify soldiers within the unit that need to have the plan completed. The Family Care Plan can be found in AR 600-20. DA Form 5035 (Family Care Plan).

Army Announces Wounded Soldier Hotline

On Monday, March 19th, the Army opened the new Wounded Soldier and Family Hotline, providing wounded and injured Soldiers and their family members with another way to resolve medical issues.

"The hotline provides an information channel for Soldiers' medical-related issues to go directly to senior Army leadership in order to improve the way the Army serves the medical needs of Soldiers and their families." said the commander of U.S. Army Human Resources Command, Maj. Gen. Sean J. Byrne.

The "Wounded Soldier and Family Hotline" can be reached from 7 a.m. to 7 p.m. (Eastern), Monday through Friday, at (800) 984-8523. The call center is under the command of the U.S. Army's Human Resources Command.

Military OneSource Offers Tips

Military OneSource has a library of resources and information available to Soldiers and their families to help them with life's challenges. Topics like "Money Matters," "Improving Your Parenting Skills," and "Transition to Civilian Life," "Deployment," and "Legal Matters" are just a few of the easily accessible areas addressed on the Military OneSource website, www.militaryonesource.com. Extension of Tax Deadlines for Combat Zone Service

Generally, deadlines for performing actions related to a Soldier's taxes are extended for the period of their service in the combat zone, plus 180 days after their last day in the combat zone. This extension applies to the filing and paying of a Soldier's income taxes that would have been due on 15 April. During the extension period, assessment and collection deadlines will be extended, and the Soldier will not be charged interest or penalties attributable to the extension period. Individual Retirement Accounts (IRAs) for Deployed Soldiers

A recent law change makes it possible for members of the military to count tax-free combat pay when figuring how much they can contribute to a Roth or traditional IRA. Until now, members of the military whose earnings came from tax-free combat pay were often barred from putting money into an IRA, because taxpayers usually must have taxable earned income. The IRA contribution limit for 2006 is \$4,000 for those under 50, and \$5,000 for those 50 and over. For more information, visit: http://www.irs.gov/newsroom/article/0,.id=101266,00.html.
