#### **Military OneSource News**

OSD has announced the new MyCAA Program Guidance and a re-opening date of October 25, 2010. Significant changes have been made to eligibility, benefit and fiscal year cap, time-limit, and programs of study.

New Financial Assistance Guidelines:

The program is available to spouses of active duty service members in pay grades E1-E5, W1-W2, and O1-02.

The maximum financial benefit will be \$4,000 with a fiscal year cap of \$2,000. Waivers will be available for spouses pursuing licensure or certification up to the total maximum assistance of \$4,000.

The program is limited to associate degrees, certification and licensures. Effective immediately, National Guard & Reserve members must be on active duty for their spouses to receive the MyCAA benefit.

Spouses who currently have an active account will be allowed to request financial assistance until Thursday, October 21, 2010. Beginning September 1, 2010, spouses may request financial assistance for classes that have a start date up to January 15, 2011. All currently approved financial assistance documents will be honored.

The program will be closed from Friday, October 22nd to Monday, October 25th so that we may ensure the infrastructure is in place to implement the new program.

#### October is Domestic Violence Awareness Month

#### TRICARE Retired Reserve Launches

For the first time, members of the Retired Reserve who are not yet age 60, the so-called "gray area" retirees, can purchase TRICARE health coverage for themselves and their eligible family members with the 1 September 2010 launch of TRICARE Retired Reserve (TRR).

This new program offers a health coverage opportunity for "gray area" Guardsmen and Reservist who served America honorably, setting a proud example for today's forces. Retired Reservists may qualify to purchase TRR coverage if they are under the age of 60 and are not eligible for, or enrolled in the Federal Employees Health Benefits (FEHB) program. They must also be members of the Retired Reserve of a Reserve component and qualified for non-regular retirement. #### **Ohio Veterans Bonus Officially Launches**

In November 2009, Ohio voters resoundingly passed Issue 1 providing a one-time Veterans Bonus for Ohio service members and surviving families. On August 24, 2010 a news release from the Ohio Attorney General's office made it official.

#### **Ohio Military Family Medical Leave Act**

The Ohio Military Family Medical Leave Act provides qualifying Ohio employees the opportunity to take unpaid leave linked to the military service of certain family members of the employee. The law became effective July 2.

Most employers with 50 or more employees are currently required to comply with the federal Family and Medical Leave Act, which provides certain employees including spouses, sons, daughters, parents or next-ofkin of service members - with up to 12 weeks of unpaid, job-protected leave annually. However, the Ohio Military FMLA takes military-related employee leave further.

Under the Ohio law, all Ohio employers with 50 or more employees are required to provide two weeks of unpaid leave for employees who are spouses, parents or individuals who have or have had custody of a uniformed services member, when that member is called for an active duty period of longer than 30 days, or injured or hospitalized while on active duty. Employees are able to take up to 10 days or 80 hours, whichever is less, once annually, under the Ohio Military FMLA.

Additionally, under the law, employers must comply regardless of whether they have 50 employees within 75 miles of the worksite - a pre-requisite of the federal FMLA.

There are some important social reasons for the law, including providing support for military members and their families.

To qualify for the Ohio Military FMLA, employees must meet several qualifications, including being employed by their employers for at least 12 consecutive months and for a minimum of 1,250 hours during the 12 months immediately preceding commencement of the leave. Employees taking leave under the new law must also first exhaust all available forms of leave, other than sick leave or disability leave; take leave no more than two weeks prior to or one week after the date of deployment; and provide employers with 14 days of notice of intended leave for active duty deployment or two days notice of intended leave for injuries (notice is not required for leave taken due to critical or life-threatening injuries).

The Ohio Military FMLA also includes extra protections for employees - it prohibits employers from interfering with, restraining or denying an employee from taking leave under the law, and from discharging, fining, suspending, expelling, disciplining or discriminating against employees who exercise their rights provided by the law. Ohio employers also must restore the employee to the position he or she previously held, or to a position with equivalent seniority, benefits, pay and other terms and conditions of employment, once the leave concludes.

## Your Finances Roth IRAs

A Roth individual retirement account (IRA) is a personal savings plan that offers tax benefits to encourage retirement savings. You can contribute up to the lesser of \$5,000 in 2009 and 2010, or 100 percent of your taxable compensation to a Roth IRA. In addition, individuals age 50 or older can make an extra "catch-up" contribution of up to \$1,000 in 2009 and 2010.Contributions to a Roth IRA are not tax deductible, but the funds grow tax deferred and distributions are tax free under certain conditions.

Prerequisites;

You have taxable compensation (i.e., wages, selfemployment income) during the year of the contribution. Your modified adjusted gross income (MAGI) for 2010 must be:

- \$105,000 or less for a full contribution if your tax filing status is single or head of household (partial contribution allowed, up to MAGI of \$120,000)
- \$167,000 or less for a full contribution if your tax filing status is married filing jointly or qualifying widow(er) (partial contribution allowed, up to MAGI of \$177,000)
- \$10,000 or less for a partial contribution if your tax filing status is married filing separately and you lived with your spouse at any time during the year (full contribution not allowed)

Note: These income ranges are for the 2010 tax year, and are indexed for inflation.

Key Strengths

- Qualified distributions are completely tax free (and penalty free)
- You can contribute after age 70½ (as long as you have taxable compensation)
- You have flexibility in withdrawing your funds prior to retirement
- You are not required to take any distributions while you are alive
- Contributions can be made even if you are covered by an employer-sponsored retirement plan
- IRAs offer a wide range of investment choices \$1,171,650 (as of April 1 2010) (and in some cases more) of IRA assets are protected in the event of bankruptcy under federal law

You can open a Roth IRA with a bank, financial institution, mutual fund company, life insurance company, or stockbroker. You may also select types of investments to fund the Roth IRA (e.g., CDs, mutual funds, annuities). Lastly you can make contributions up to the due date of your federal income tax return for that year (usually April 15 of the following year), not including extensions. If you have any additional questions, please contact your financial institution.

The Operation: Military Kids (OMK) program held its 6<sup>th</sup> annual camp at Kelleys Island on August 9-13, 2010. Youth ages 9 to 15 were housed at the two camp sites with

the Erie County 4-H Camp hosting our 9-11 year old campers and Camp Patmos hosted the 12 to 15 year olds. This enabled us to offer a program of activities geared more specifically for the two age groups. At camp, the youth experience all of the activities that are traditional at any 4-H camp, such as swimming, canoeing, campfires, crafts, and sleeping in cabins. Set on the shores of Lake Erie, campers took advantage of the beautiful natural surroundings. Teen campers had the opportunity to go biking, boating, swimming, sailing, kayaking, wakeboarding, and water skiing. Other program features included a climbing wall staffed by members of the Ohio National Guard Recruiting and Retention Battalion.

Other activities were aimed to help children develop teamwork and leadership skills. One of these activities is a community service project to benefit the Kelleys Island community. Teams of campers continued a community service project that began in 2009. This year they laid the second part of a paver sidewalk to improve access to the local Veterans' Memorial in the center of town. The sidewalk was dedicated in a short ceremony on the last day of camp.

A unique aspect of the camp is the participation of military service members in the camp program. Each day the "Military Moments" portion of the program is devoted to discussing and demonstrating military values such as honor, loyalty, courage, commitment, integrity, and selfless service. A highlight of the week was when Major General Matthew Kambic, Assistant Adjutant General for the Army, led a team of military leaders from all five branches of the service that landed in a Chinook helicopter on the camp field. Other donors and supporters attended this day, which included a BBQ lunch provided by Smokin Brothers BBQ on the beach. General Kambic spoke to the campers about loyalty and selfless service.

Back by popular demand, members of a Navy Special Warfare team (aka Navy SEALs) conducted a rescue demonstration and led PT activities. One of the all-camp activities was the camp version of Amazing Race, which had the campers rotating to different stations throughout camp and engaging in various fun challenges (e.g., marshmallow catching, cup stacking, flag folding). All of these activities are geared towards building camaraderie, connections, resilience, and pride in being part of a military family.

Another special highlight of the week was also on Wednesday, as we hosted nearly 60 of our VIP's that day that included many of our donors and special supporters of OMK. They all came to take in the great experience of our camp and see for themselves the great impact that this event has on the youth that are able to participate. The USO of Central Ohio held the title of our single largest donor with a donation in the amount of \$22,000 to Operation: Military Kids for this event. Without the support of the USO of Central Ohio and many others this camp would not be possible.
