Ohio National Guard conducts health, welfare checks during Operation Guardian Comfort

COLUMBUS, Ohio — In response to severe storms and high winds that knocked out power June 29 across more than half of Ohio, Gov. John Kasich ordered a contingent of the Ohio National Guard to state active duty.

Dubbed Operation Guardian Comfort, about 200 Ohio National Guard Soldiers and Airmen were deployed to Franklin and Montgomery counties July 1-3. They went door-to-door to check on the health and welfare of residents in affected areas and provide them basic information and telephone numbers if they need assistance.

“Caring for our neighbors, lending a hand in our community where it’s needed, is part of the Ohio National Guard’s mission,” said Maj. Gen. Deborah A. Ashenhurst, Ohio adjutant general. “Our members (were) especially looking to ensure senior citizens, young children and those with sensitive medical conditions (were) alright.”

Soldiers and Airmen from the Ohio National Guard’s Joint Task Force 16 provided personnel for the mission. Guard members canvassed areas identified by the Ohio Emergency Management Agency — in conjunction with other state agencies and county EMAs — to be most in need, based on factors including: population, concentration of homes without power, as well as the number of self-reported residents who are elderly or may have medical conditions.

Initially, a joint force of about 150 Soldiers and Airmen worked in Franklin County and a group of about 50 Guard members were dispatched to Montgomery County, but by the end of the operation all 200 Guard members were working in designated areas within Franklin County.

“Operation Guardian Comfort is a mission which enables the Air and Army National Guard to fully embrace the Citizen-Soldier side of the National Guard,” said Lt. Col. Dave Brucker of the 178th Intelligence, Surveillance and Reconnaissance Wing in Springfield, Ohio.

Airmen from the 178th combined their efforts with Ohio National Guard Soldiers to check on an estimated 900 homes in Montgomery County, according to Maj. Justin Chapman, 178th ISRW mission operations officer.

“I was glad to be there for the people of Montgomery County,” said Senior Airman Jeremiah Taylor, 178th Security Forces Squadron. “They were happy we were there.”

Don't miss out on VRAP

There are thousands of veterans nationwide signing up for the Veterans Retraining Assistance Program (VRAP) nationwide. Don't be left behind on this VA program intended to get unemployed veterans aged 35-60 re-trained and re-employed. The deadline to apply is September 30.

VRAP is part of the VOW to Hire Heroes Act of 2011, passed by Congress last year. The program offers up to 12 months of job training assistance under the Montgomery G.I. Bill at the rate of \$1,473 per month. The training is aimed at filling skills currently in high demand for employment. As noted above, applications will be accepted for the program until September 30.

Please note that applications must be made online through the VA's eBenefits program.

Brown County receives community based outpatient clinic

We want to pass along some great news for veterans in Brown County....the VA will be opening a Community Based Outpatient Clinic (CBOC) in your area!

The VA announced July 19 that Brown County will be getting its own Community Based Outpatient Clinic in the Georgetown area within the next year, one of 13 new clinics in nine states that the VA is opening. Brown County veterans will now be able to receive medical care closer to home, rather than going to Cincinnati or neighboring Clermont County.

On the plus side, Ohio is one of only nine states where a new clinic will open, which shows how seriously the VA takes the needs of Ohio's veteran population.

Veterans who have questions or concerns about benefits, or want to see what they're eligible for (federal, state, the Ohio Veterans Bonus for Persian Gulf, Iraq and Afghanistan-era vets, or local area financial assistance) can apply for these benefits, through their county veterans service office at 1-877-OHIO-VET (1-877-644-6838).

Education Benefits

Veterans interested in starting their own small business can use the Montgomery GI Bill education benefits to pay for required training. VA will only pay for programs offered by the Small Business Development Centers (SBDC) or Veterans Corporation.

Education benefits can also be used to pay for training at Non-Degree-College Institutions that will lead to a certification in the following programs:

- Barber/Beautician Schools
- EMT Certification
- HVAC Certification
- Truck Driving

In cases where a license or certification is required for the small business, veterans can receive reimbursement for licensing and certification tests taken on or after March 1, 2001. In order to find out if the test is approved for the GI Bill, you can call 1-888-GIBILL-1 (1-888-442-4551).

Access to Capitol

VA does not make loans or grants for the startup or expansion of a small business. The Small Business Administration (SBA) is an agency that deals with small business financing.

Loans

All small business loans are determined on a basis of credit-worthiness. Financial institutions take into account several factors including: a business profile, description of how loan funds will be used, collateral offered, business financial statements and personal financial statements. Generally, small business loans are repaid in five to seven years. There are several SBA small business loan programs established, which are described on the SBA financing website at

Patriot Express Loan

On June 14th, 2007, SBA launched a loan program for Veterans called **Patriot Express**. Patriot Express is part of the SBA 7(a) small business loan program.

Grants

Grants are a form of funding for specific federal research and social programs. Contrary to popular belief, there are no federal grants made specifically for the purpose of starting a business. Organizations can use the **Grants.gov** website to electronically find and apply for competitive grant opportunities from all Federal grant-making agencies. **Grants.gov** is THE single access point for over 900 grant programs offered by the 26 Federal grant-making agencies.
