- Applicants must meet TIG/TIS requirements for promotion to TSgt at the time of application.
- Applicants must have a current/passing Fitness Assessment.
- Applicants must not have any overdue EBPs or GPC payments.
- If recently transferred from a sister service, member must have ALS completed at the time of application
