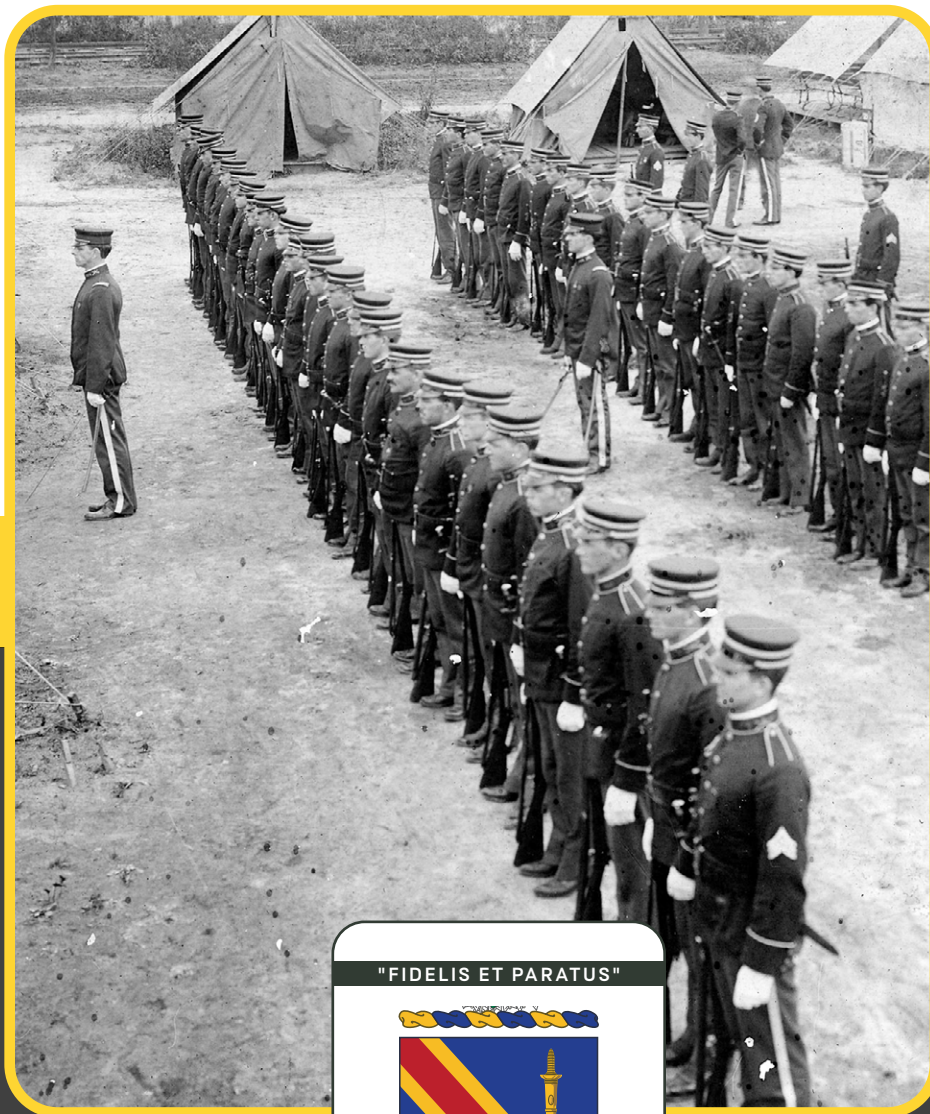

COMPANY G, 237TH SUPPORT BATTALION

Company G, 237th Support Battalion was organized on Dec. 10, 1874, in Findlay, Ohio as the Findlay Guards. Capt. James Wilson, a veteran of the Mexican and Civil Wars, organized the unit and served as the first commander. The company was assigned to the 11th Infantry Regiment as Company B in 1876 and redesignated as Company A, 11th Infantry Regiment in 1879. On June 1, 1883, the 11th was redesignated as the 2d Infantry Regiment. The company was mustered into federal service on May 10, 1898, for the War with Spain. After training in Georgia and Tennessee, the company returned to Ohio in early 1899 and was mustered out of federal service.

The company returned to active service in June 1916 and served along the Mexican Border until the following March. A few months later, in July 1917, the company returned to federal service for World War I. The 2d Infantry was broken up during a general reorganization in the fall of 1917, with most of Company A transferred to Company G, 145th Infantry, 37th Division. It was under this designation the unit fought in France and Belgium during the war.

The company reorganized in Findlay in December 1920, and on July 1, 1921, was redesignated as Company C, 148th Infantry. On Oct. 15, 1940, the company returned to federal service and trained at Camp Shelby, Miss. During World War II, the company fought in the Pacific Theater with the 37th Infantry Division, earning the Presidential Unit Citation for its part of the fighting on Luzon.

Reorganized in Findlay in 1947 as Company F, 148th Infantry, the unit was sent to Camp Polk, La. in January 1952, for the Korean War and was reorganized in Ohio in January 1954, once again as Company C, 148th Infantry. Between 1959 and 2001, the unit underwent a number of reorganizations, but remained an element of the 148th Infantry. On Sept. 1, 2001, the Findlay Armory was closed and Det. 1, Headquarters and Headquarters Company, 1st Battalion, 148th Infantry was consolidated with the parent unit in Lima.

The Lima element was organized on Jan. 14, 1875, as the Melanchton Light Guard. Capt. Luther M. Meily organized the unit and served as its first commander. Meily would later serve as adjutant general of Ohio. Like its counterpart in Findlay, the Lima company was assigned to the 11th and later the 2d Infantry Regiment as Company C. The company served on active duty during the War with Spain, Mexican Border Service and World War I.

While the company was initially reorganized after the war as an infantry company, the unit was converted to a quartermaster company in 1936. It was under this branch that the unit entered service for World War II and after reorganizations in 1942 and 1943, was finally designated as the 37th Quartermaster Company. The company provided logistical support to the 37th Infantry Division during their march across the Pacific.

In January 1947 the unit was reorganized in Lima as Service Company, 148th Infantry. A series of reorganizations, starting in 1959, reorganized the unit as a headquarters company. First for the 2d Battle Group, 148th Infantry, then, in 1963, for the 2d Battalion, 148th Infantry, and finally in 1968 for the 1st Battalion, 148th Infantry.

In 1993, the company was consolidated with Company A, 1st Battalion, 148th Infantry, stationed in Van Wert. The unit was first organized on June 11, 1929, as the 135th Collecting Company and served with the 37th Infantry Division during World War II as Company B, 112th Medical Battalion, earning two Meritorious Unit Commendations. From 1947 until 1993, Van Wert was home to various elements of the 148th Infantry.

In October 2001, Lima's Headquarters and Headquarters Company, 1st Battalion, 148th Infantry was part of the first Ohio National Guard mobilization in support of the War on Terrorism. While the battalion was spread across the midwest securing critical defense infrastructure, the battalion headquarters operated out of Fort Knox, Ky. providing administrative, training and logistical support for the various subordinate elements until October 2002. In 2004-2005, the company was deployed to Kosovo in support of NATO peacekeeping operations, earning the Army Superior Unit Award.

On Sept. 1, 2007, the company was reorganized as Company E, 237th Support Battalion, and served as the forward support company for the 1st Battalion, 148th Infantry Regiment. The company mobilized to Kuwait in 2008 and Afghanistan in 2011-2012, where the unit was awarded the Meritorious Unit Commendation. On Sept. 1, 2018, Company E was redesignated under its present designation, Company G, 237th Support Battalion, and continues its role as the forward support company of the 1st Battalion, 148th Infantry Regiment.

HERALDIC ITEMS



DISTINCTIVE UNIT INSIGNIA

Description/Blazon: A Gold color metal and enamel device 1 1/8 inches (2.86 cm) in height overall consisting of a shield blazoned: Azure, a bend Or charged with a bendlet Gules between a sheathed Roman sword paleways, point to base, and an oak tree eradicated of the second. Attached below the shield a Gold triparted scroll inscribed "FIDELIS ET PARATUS" in Red letters.

Symbolism: Blue is the color traditionally associated with Infantry, the branch of the parent organization. The sheathed Roman sword, adapted from the Spanish War service medal, represents service in the United States during the Spanish-American War. The oak tree and the gold bend charged with the red bendlet commemorate service during World War I by the parent unit. The oak tree symbolizes participation in the Meuse-Argonne Operation, and the bend charged with the bendlet the service in the defensive sectors in Alsace and Lorraine. The Arms of Alsace incorporate a gold bend and the Arms of Lorraine a red bend. The motto translates to "Faithful and Ready."

Background: The distinctive unit insignia was originally approved for the 2d Battalion, 372d Infantry Regiment on 23 April 1929. It was rescinded on 6 May 1942. It was approved for the 372d Infantry Battalion on 24 October 1951. It was rescinded on 28 March 1963. The insignia was reinstated and redesignated for the 372d Maintenance Company with the description and symbolism revised on 17 September 1992. It was redesignated for the 237th Support Battalion effective 1 September 2007.

COAT OF ARMS

Description/Blazon:

Shield: Azure, a bend Or charged with a bendlet Gules between a sheathed Roman sword paleways, point to base, and an oak tree eradicated of the second.

Crest: That for the regiments and separate battalions of the Ohio Army National Guard: From a wreath Or and Azure, a sheaf of seventeen arrows Argent bound by a sprig of buckeye (Aesculus glabra) fructed Proper (two leaves with bursting burr).

Motto: FIDELIS ET PARATUS (Faithful and Ready).



Symbolism: Blue is the color traditionally associated with Infantry, the branch of the parent organization. The sheathed Roman sword, adapted from the Spanish War service medal, represents service in the United States during the Spanish-American War. The oak tree and the gold bend charged with the red bendlet commemorate service during World War I by the parent unit. The oak tree symbolizes participation in the Meuse-Argonne Operation, and the bend charged with the bendlet the service in the defensive sectors in Alsace and Lorraine. The Arms of Alsace incorporate a gold bend and the Arms of Lorraine a red bend. The crest is that of the Ohio Army National Guard.

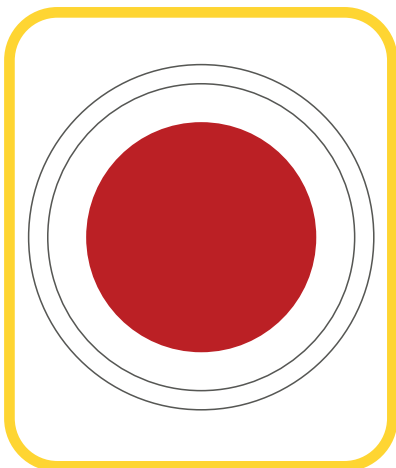
Background: The coat of arms was originally approved for the 2d Battalion, 372d Infantry Regiment on 20 April 1929. It was rescinded on 6 May 1942. It was approved for the 372d Infantry Battalion on 24 October 1951. It was rescinded on 26 March 1963. The insignia was reinstated and redesignated for the 237th Support Battalion with the symbolism revised effective 1 September 2007.

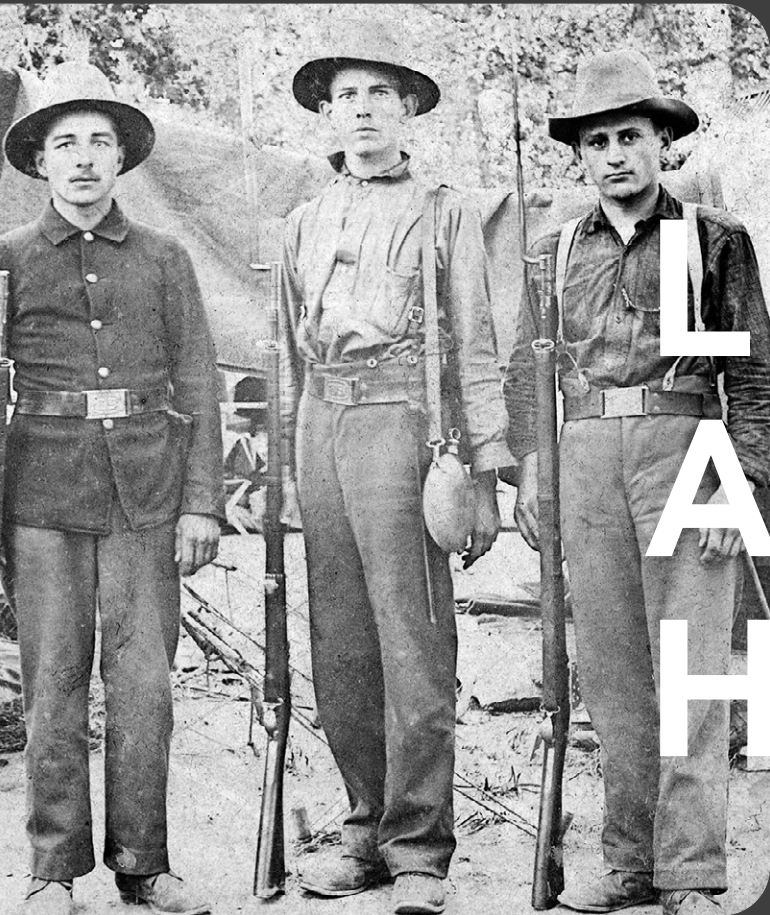
SHOULDER SLEEVE INSIGNIA

Description/Blazon: On a white disc 2 1/4 inches (5.72 cm) in diameter a red disc 1 1/2 inches (3.81 cm) in diameter.

Symbolism: The red and white disc is taken from the State Flag of Ohio.

Background: The shoulder sleeve insignia was originally approved for the 37th Division on 5 November 1918. It was redesignated for the 16th Engineer Brigade on 9 July 1968. It was cancelled on 4 December 1969. The insignia was reinstated and redesignated effective 1 September 2007, for the 37th Infantry Brigade Combat Team, with the description updated and a symbolism added.

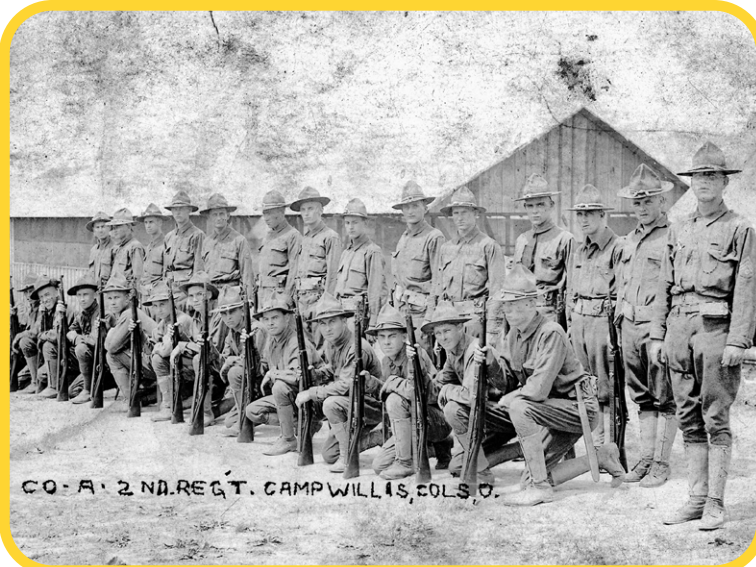

Ordered into active Federal service 15 October 2011 at Lima; released from active Federal service 17 November 2012 and reverted to state control

Reorganized and redesignated 1 September 2018 as Company G, 237th Support Battalion

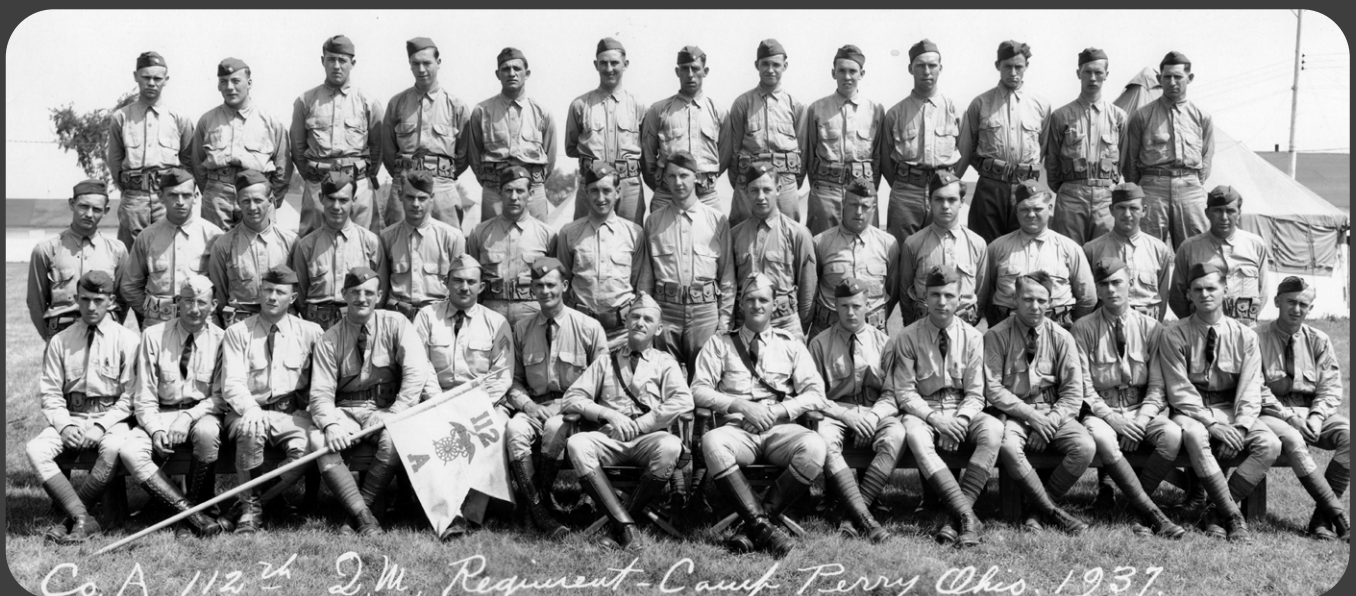

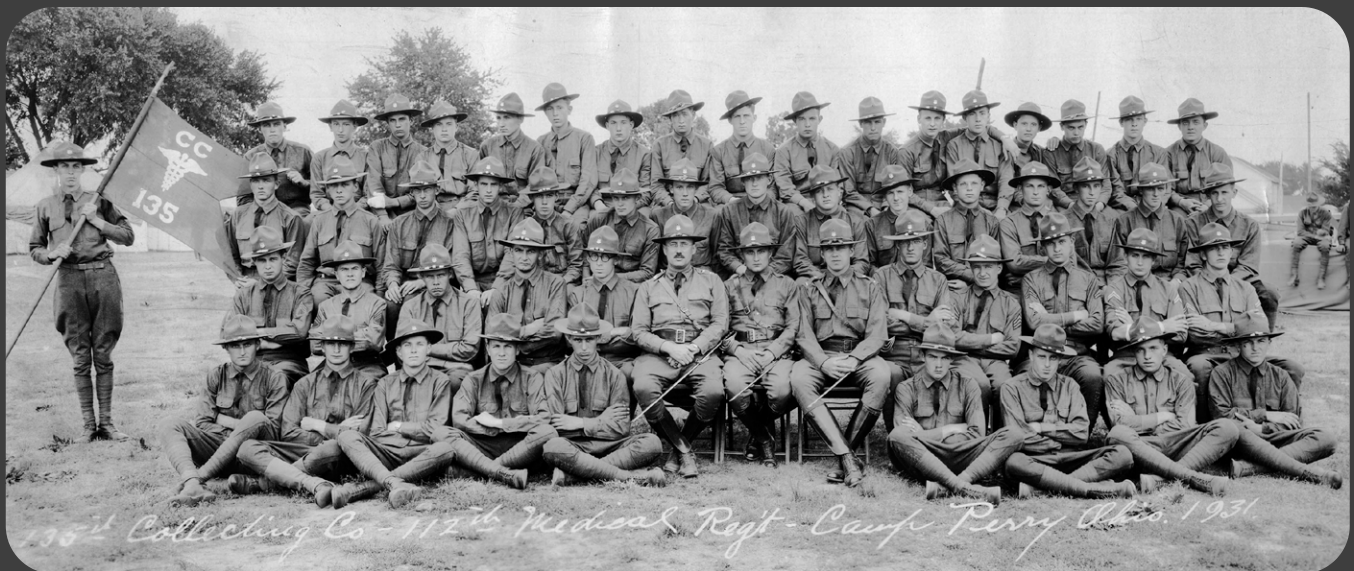
