Governor DeWine,

This past year, with your leadership and support, your Ohio National Guard and State Defense Force members successfully completed missions to respond when called by our great state and nation.

Readiness is our number one priority. From planned deployments overseas to rapid response for emergency situations, we were ready to serve. More than 3,000 members deployed for federal missions across the globe. After tornados hit the Indian Lake area in spring 2024, the 200th RED HORSE responded to provide engineering assessments and debris removal.

Cybersecurity continues to be a major initiative. This year, the 179th Airlift Wing in Mansfield transitioned to the nation's first Air National Guard cyberspace wing. This unit will continue the transition to its new mission in the coming fiscal year. The Ohio Cyber Reserve assisted Fremont City Schools after they were hacked and the city of Cleveland after a ransomware attack.

This fiscal year, we celebrated our 30th anniversary of collaboration with Hungary through the State Partnership Program. This historic program helps to promote regional stability and ensures our partnered nations can effectively work together on mutual missions.

Our Citizen-Airmen and Citizen-Soldiers have stepped up in numerous ways in the past year. I am honored to serve with the more than 15,000 men and women whose dedication each and every day shows why the Ohio National Guard lives up to the motto

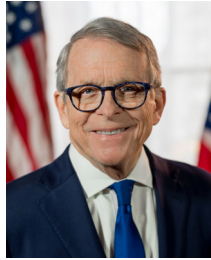

# ADJUTANT GENERAL'S DEPARTMENT & OHIO NATIONAL GUARD LEADERSHIP



**GOVERNOR**  
**Mike DeWine**

The governor is the commander in chief of the Ohio National Guard and, as such, has the authority to activate the Ohio National Guard to support and assist local authorities during state emergencies or for homeland defense.



**ADJUTANT GENERAL**  
**Major General**  
**John C. Harris Jr.**

The adjutant general is a member of the governor's cabinet and is responsible for the command of the Ohio Army National Guard, Ohio Air National Guard, and State Defense Force. The adjutant general supervises the heads of these components in the day-to-day operation and management of the readiness, fiscal, personnel, equipment, and real property resources of the agency.



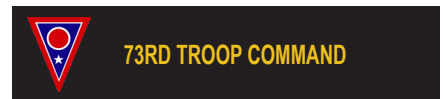
**DIRECTOR OF THE JOINT STAFF**  
**Brigadier General**  
**Jeffrey B. Watkins**

The director of the joint staff is responsible for executing joint Ohio National Guard operations, actions, and activities to help prepare for an effective response to contingency operations in a federal or state emergency. The director oversees the joint staff and advises the adjutant general on issues and policies relating to the operations, sustainment, and administration of the Ohio National Guard.



**ASSISTANT ADJUTANT GENERAL FOR ARMY**  
**Brigadier General**  
**Matthew S. Woodruff**

The assistant adjutant general for Army is responsible for establishing policies, priorities, and oversight for the readiness of the Ohio Army National Guard in six brigade-level major subordinate commands.





**COMMAND SENIOR ENLISTED LEADER**  
**Command Sergeant Major Scott M. Barga**

The command senior enlisted leader (CSEL) serves as the adjutant general's principal advisor on all enlisted matters affecting training, readiness, utilization, health of the force, and enlisted professional development. As the highest-ranking enlisted member of the Ohio National Guard, the CSEL provides direction for the enlisted force, communicates command policies and initiatives, and ensures Soldiers and Airmen adhere to established organizational standards and goals.



**ASSISTANT QUARTERMASTER GENERAL**  
**Colonel (Retired) Rodney D. Tansill**

The assistant quartermaster general is responsible for all property of the Adjutant General's Department. The assistant quartermaster general heads the Directorate of Installation Management and Resources (DIMR), which oversees energy and environment, facilities management, state finance, state contracting, planning and programming, resource management, state inventory and business services, geospatial information services, and electronic security systems.



**UNITED STATES PROPERTY AND FISCAL OFFICER**  
**Colonel Thomas P. Caldwell**

The United States Property and Fiscal Officer (USPFO) serves in Title 10 active-duty status and is responsible for oversight and accounting of federal funds and property in the possession of the Ohio National Guard. The USPFO ensures that federal funds are obligated and expended in compliance with applicable statutes and regulations, as directed by the chief, National Guard Bureau, and the appropriate service secretaries; the USPFO directs inventories, audits, and investigations to ensure accountability and compliance.



**COMMANDER**  
**Brigadier General (OH) Larry Pinkerton**

The State Defense Force (SDF) is commanded by a brigadier general (non-federally recognized) who reports directly to the adjutant general and maintains a staff of about 30 personnel. The SDF was a significant part of the state of Ohio's COVID-19 response, supporting distribution missions in addition to augmenting staffing at multiple state agencies.



**ASSISTANT ADJUTANT GENERAL FOR AIR**  
**Brigadier General David B. Johnson**

The assistant adjutant general for Air is responsible for directing the Ohio Air National Guard's day-to-day operations and administration and helping establish policy to ensure mission readiness of four wings and support units.

# ADJUTANT GENERAL'S DEPARTMENT & OHIO NATIONAL GUARD DUAL RESPONSIBILITIES

The Adjutant General's Department and Ohio National Guard represent the citizens, communities, and values of this great state.

## OUR COMMITMENT IS TO THE FOLLOWING IDEALS AND CONCEPTS:

### READINESS

The phrase "Always Ready, Always There" captures our commitment to respond to an increasingly complex set of international, national, and state issues – evolving threats and unfamiliar situations.

### INTEGRITY

Our duty is to consistently exemplify the ideals of this nation and state, to objectively uphold and defend the Constitution of the United States and the state of Ohio against all enemies, foreign and domestic.

### INNOVATION

To leverage the capacity of cohesive, collaborative, and engaged teams to confront the challenges ahead of us as a nation and a state. To draw from each member's experiences, perspectives, and background to accomplish the mission and serve our citizens.

### DIVERSITY

To resemble and represent the communities, state, and nation we serve. To allow all who qualify to serve to their fullest potential while achieving their personal and professional goals.

### COMMUNITIES

The Ohio National Guard represents 26% of all Department of Defense employees in Ohio. The Ohio National Guard has nearly as many uniformed members as all Reserve Component and active-duty members in Ohio combined (28%). We are Ohio — serving from over 55 facilities and installations across the state.

The Ohio National Guard is a unique military enterprise, with a dual mission that consists of federal and state roles, administered by the Ohio Adjutant General's Department. The adjutant general is responsible to the governor of the State of Ohio and the president of the United States. These two responsibilities involve preparing for and responding to current and emerging homeland security threats, homeland defense initiatives, and national defense roles and missions.

For state missions, the governor, through the adjutant general, commands Guard forces. The governor can call the National Guard into action during local or statewide emergencies, natural disasters, or civil disturbances. In addition, the president can activate the National Guard for participation in federal missions, including deployment of Guard units worldwide. When federalized, Guard units are commanded by the combatant commander of the geographic region in which they are operating.

The Adjutant General's Department comprises the Ohio Army and Air National Guard, as well as the State Defense Force, which is composed of the Ohio Military Reserve, Ohio Naval Militia, and the Ohio Cyber Reserve. Each entity is distinctly organized with multiple capabilities.

- The adjutant general and the assistant adjutants general for Army and Air are State of Ohio employees serving in a federally recognized status.
- The majority of individuals serving in the Ohio National Guard are "traditional" Guard members, known as Citizen-Soldiers and -Airmen. They serve part time, have civilian jobs, and live throughout the state.
- The Ohio National Guard retains a full-time unit staff at Joint Force Headquarters of Active Guard Reserve members, Title 32 dual status federal technicians (uniformed military members), and Title 5 federal technicians (non-uniformed civilians).
- The Adjutant General's Department is authorized 300 state employees that manage state funds and resources, and operate and maintain the agency's facilities and programs.
- The State Defense Force does not utilize full-time unit staff.
- State active duty is the governor's authority to mobilize the Ohio National Guard and State Defense Force.

Any current or retired Ohio National Guard member or current state employee of the Ohio Adjutant General's Department can receive \$2,000 per enlistment for any lead once they successfully enter military service and report for initial military training. There can be a delay between enlistment and when the recruit reports for initial military training

The Ohio National Guard receives federal funding through National Guard Bureau that encompass funding for operations; constructing, renovating, and sustaining facilities; acquiring and maintaining equipment; and compensating (pay/benefits) uniformed members of the Ohio National Guard and civilian employees. State appropriations augment the administrative costs of the Ohio National Guard and the Adjutant General's Department (including elements of the State Defense Force), and includes funding for State of Ohio employee compensation, state active duty, the state scholarship program, and state recruitment incentive bonuses.

## TOTAL WORKFORCE **15,747**

Among monthly or scheduled training, annual training, and deployments, the Ohio National Guard is administered, trained, and equipped through the efforts of the nearly 20% of its workforce that makes up the full-time staff. They are the core of the force, ensuring that traditional Guard members are always ready to serve.

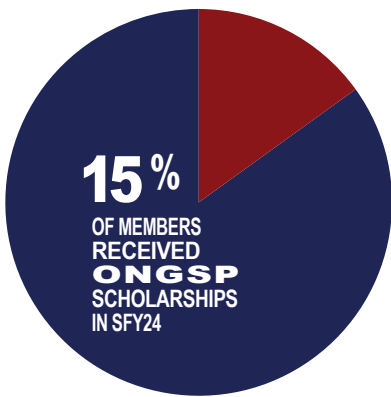
### SELECTED RESERVE INCENTIVE PROGRAM

The Army National Guard Selected Reserve Incentive Program (SRIP) offers monetary bonuses to recruit or retain members to help achieve personal end strength objectives. Bonuses are used to increase new enlistments; extension of existing enlistment contracts and reenlistments; affiliation or transfer into the organization from other branches or components; and entry into or remaining in units or career fields that have vacancies or that require highly specialized skillsets.

## OHIO NATIONAL GUARD SCHOLARSHIP PROGRAM

The Ohio National Guard Scholarship Program (ONGSP) is a benefit provided by the State of Ohio and earned by Guard members for their service. It is not a grant or an entitlement program.

**ONGSP's Undergraduate Degree Program** awarded 4,121 scholarships in FFY23. State-assisted institutions are paid 100% of students' tuition, which has been defined by the Ohio Board of Regents to include basic and instructional fees, while private schools are paid the average per-student tuition charges of state-assisted universities.

The ONGSP expanded to include the **Credentials, Licensure and Certification Program (CLCP)** in 2022, which offers trade certification, credential-certifying, and licensing programs to members. The CLCP pays tuition costs for any of the 395 approved Non-Traditional Education Programs at any participating college or university after federal or Department of Defense educational assistance funding has been applied.

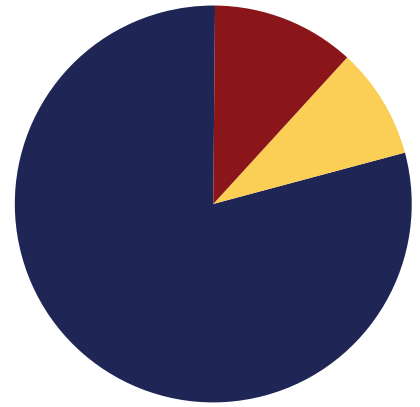

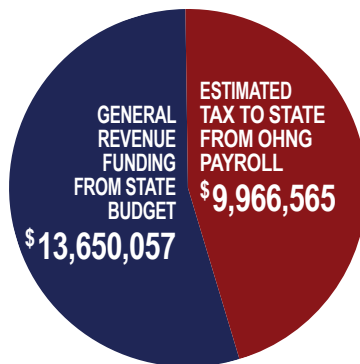

# STATE FUNDING

## GENERAL REVENUE FUND

State General Revenue Funds are derived from Ohio income tax revenues. They complement federal cooperative agreements (much like grants) for the administration of the Ohio National Guard and provide the necessary amount of administrative, maintenance, utility, and payroll funded by the state.

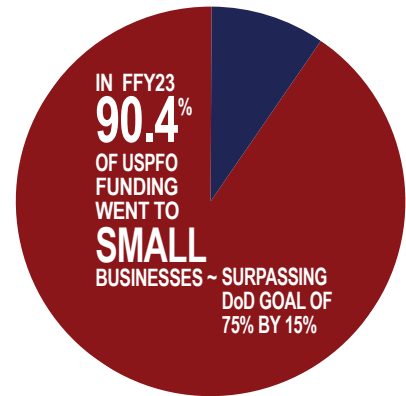

### SMALL BUSINESS PROGRAM

The U.S. Property and Fiscal Office (USPFO) awards contracts with businesses to serve Ohio National Guard members and their Families for items including: IT services; health care; food and lodging; office furniture; video recording; catering; construction and maintenance, firefighting equipment; and pre-fabricated and portable buildings. For the past several years, the Ohio National Guard has consistently surpassed goals set forth by the Department of Defense for awarding contracts to small business.

### SIMPLIFIED ACQUISITION THRESHOLD

Policy guidance states that 71.5% of all contracts under the amount of \$250k be offered to eligible small business first, if applicable. OHNG awarded 93.33% to small businesses in FFY23.

## ENERGY INITIATIVES

The Ohio National Guard and Adjutant General's Department continue efforts to meet mandated energy conservation goals by pursuing alternative energy sources, such as wind and solar, to reduce overall consumption as well as the resulting carbon footprint. During the last decade, reducing consumption and conservation of natural resources have been a major focus, aided by successfully implementing several energy reduction initiatives.

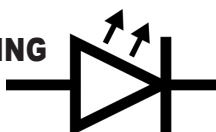
Currently, 39 energy audits are being done for OHNG facilities to provide a baseline for energy and water performance that create projects to provide consumption reductions and a simple payback within 12 years. Energy and water conservation measures from SFY24 energy audits will be targeted for SFY25 funds.



### ELECTRIC VEHICLE CHARGING

March 15, 2024

An electric vehicle policy was signed by the adjutant general and charging stations were installed at Maj. Gen. Robert S. Beightler Armory in Columbus.



### LED LIGHTING PROJECTS

**Reduce electric consumption by 345,531 kWh/yr**  
Projects to switch to LED lights were completed, or in progress, at the Mansfield Field Maintenance Shop; Youngstown, Alliance and Green armories; Camp Sherman JTC; and the Combined Support Maintenance Shop at DSCC.

## ENVIRONMENTAL INITIATIVES

The Ohio National Guard continues to ensure the sustainability and availability of training lands and facilities essential for Soldier training and unit readiness. By focusing on environmental training, regulatory compliance, and natural resource conservation, the Ohio National Guard Environmental Office has made significant contributions to the readiness of the state's Soldiers and the efficiency of the joint training facilities.

### ONGOING MISSION

A munitions removal contract at Camp A. Garfield Joint Military Training Center, awarded in 2021, was completed in 2023. Tree clearing and geophysical investigations were done in early 2024. Munitions removal is ongoing and expected to finish in 2025, restoring the area to safely be used for military training.

In March 1943, an explosion at Igloo 7-D-15 at the former Ravenna Army Ammunition Plant (RVAAP) led to initial contamination concerns. Investigations by the RVAAP Restoration Program, a joint effort between Ohio Army National Guard and National Guard Bureau, ran from 2002 to 2019. It was determined that munitions removal was necessary.

### MILCON SUPPORT

The Ohio National Guard secured a floodplain waiver to construct a readiness center at Camp Perry, which lies within the 100-year floodplain according to the Federal Emergency Management Agency.

#### This required collaboration with:

- Facilities Management Office
- National Guard Bureau
- Ohio Department of Natural Resources
- Department of the Army.

The construction includes mitigation measures that entail elevating the building above the floodplain to address flood risks from climate change and Lake Erie conditions.

### TROOP LABOR PROJECTS

The environmental team assisted the 16th Engineer Brigade and the 200th RED HORSE Squadron with project planning and environmental compliance for annual training missions.

#### Key projects included:

- Wayne National Forest Innovative Readiness Training for road rehabilitation.
- Addressing drainage issues at Camp Sherman JTC's motor pool, and relocating Camp Perry JTC's helicopter landing pad from the future readiness center site.

### MISSION SUPPORT

The Ohio Army National Guard secured a 30-page programmatic agreement from the U.S. Fish and Wildlife Service, covering all listed bat species at Camp James A. Garfield JMTC.

#### This agreement:

- Streamlines operations, allowing military exercises and other activities without consultations, saving significant time and effort.
- Eliminates the need for expensive basewide surveys, which would cost over \$250,000 every five years.

## OPERATION GUARDIAN TWISTER

On March 14, a severe weather event resulted in extensive damage across multiple counties. Public infrastructure and communities were significantly impacted. On March 17, the Governor DeWine declared a state of emergency in 11 affected counties: Auglaize, Crawford, Darke, Delaware, Hancock, Licking, Logan, Mercer, Miami, Richland, and Union. Airmen from the 200th RED HORSE deployed an engineer assessment team to Logan County to identify personnel and equipment requirements to support recovery operations in the impacted areas. The 200th RED HORSE assisted with hauling debris from state routes 235 and 33.

Members of the Ohio National Guard stand ready to serve their state at a moment's notice, to ensure the protection of life and property, and to preserve peace, order, and public safety. This includes emergency response to public health pandemics and natural disasters, homeland defense, law enforcement and local government support, and other state government functions.

### CYBER GUARDIAN FOXTROT

On May 6, the Ohio Cyber Reserve was notified of a ransomware attack within the Fremont City School District; a \$500,000 ransom was demanded. The team deployed May 7 and began restoring the network to the school's control. The OhCR team contained and eradicated the entity from the network, restored control, and provided the school's IT team guidance to restore the network by May 10.

### CYBER SHIELD (TRAINING)

A team of six OhCR members traveled to Virginia Beach, Virginia for the longest-running and largest unclassified Department of Defense cyber defense exercise May 31 to June 14. Team members took on numerous roles to help develop and train cyber forces in network defense and incident response. More than 900 National Guard Soldiers, Airmen and civilians from throughout the United States participated.

### CYBER OPERATION GUARDIAN CHARLIE

On June 9th, the OhCR was activated (and on-site within two hours of notification) to lead an operation dealing with a ransomware attack on the City of Cleveland's networks. A \$5.8 million ransom was demanded. A team of 12 OhCR members and one OHARNG officer worked with multiple organizations throughout the week to include IT personnel with the city and Cuyahoga County as well as external agency partners like the FBI. By the end of the week, the incident response team contained the attacks, eradicated all elements, and prepared the city IT team to recover data and networks by June 14.

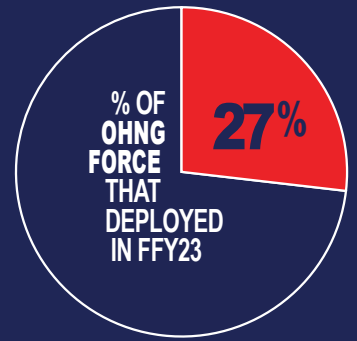

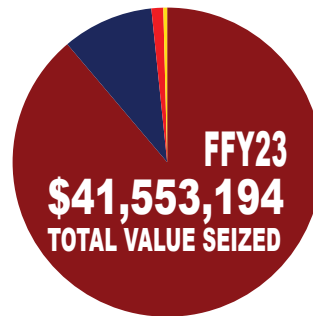
**736 ARRESTS**

The Ohio National Guard Counterdrug Program supported 45 federal, state and local agencies, including eight new partnerships, to enhance efforts to anticipate, deter, and defeat the threat of illegal substances, trafficking, and violence in Ohio. # OHIO NATIONAL GUARD HISTORY

## JULY 25, 1788

### NORTHWEST TERRITORY MILITIA

The Ohio National Guard was established on July 25, 1788, in Marietta, Ohio as the Northwest Territory Militia. This early military force was modeled after the European system of the Common Militia – ordinary citizenry who were liable to perform military duty in the event of an emergency. The laws directed that “all male inhabitants between the age of fifteen and fifty, shall be liable to and perform military duty.”



## 1803 OHIO MILITIA

When Ohio achieved statehood in 1803, the organization became known as the Ohio Militia. The Common Militia formed the basis of Ohio’s contribution in the first half of the 19th century and was augmented by independent militia companies formed in many of Ohio’s major cities. Nearly 319,000 Ohioans served in the Union Army during the Civil War and 144 of them were awarded the Medal of Honor. This includes the first recipient, Jacob Parrott of the 33rd Ohio Volunteer Infantry.



## 1903 MILITIA LAW OF 1903

In 1903, the federal government enacted the Militia Law of 1903, which gave increased federal funds and equipment to the National Guard. The bill was sponsored by Charles Dick, a congressman from Canton and a major general in the Ohio National Guard. The act transformed our nation’s militia into the modern National Guard.



## 1864 OHIO NATIONAL GUARD

In 1864, an act of the Ohio General Assembly changed the name of the Ohio Militia to the Ohio National Guard. Throughout the late 19th century, the Ohio National Guard transformed in to the more permanent and structured militia force that we know today. Companies were formed in each city or town that could support it. Battalions and regiments were then organized regionally. Weekly drills and summer encampments sharpened the troops’ military capabilities.



## 1950s OHIO NATIONAL GUARD SPLIT INTO ARMY & AIR

Following World War II, the Ohio National Guard was split into Army and Air National Guard components, as occurred nationwide. Both formations remained a vital piece of national defense during the many decades of the Cold War. Numerous federal activations tested the Citizen-Soldiers' and Citizen-Airmen's professionalism, and changes to federal standards ensured Ohio units were ready to answer the call here and abroad.



## WWI, WWII

The first half of the 20th century demonstrated the new National Guard's importance to the state, country, and world. Ohio's contribution to the American Armies abroad in both World Wars was extensive and was built primarily around the 37th "Buckeye" Division. At home, the Buckeyes remained busy responding to the needs of their fellow Ohioans in response to natural disasters as well as many instances of civil and labor unrest.



## 2001

Following the 9/11 terrorist attacks on American soil in 2001, the Ohio National Guard has demonstrated the evolution of the Guard from a strategic reserve to an operational force. Buckeye Soldiers and Airmen have performed every assigned mission during the War on Terrorism and integrated effortlessly into the national defense. Ohio National Guard members continue to answer the call to support their fellow citizens throughout Ohio and nationwide.

## MUCH HAS CHANGED

since the Ohio National Guard's founding nearly 240 years ago. Uniforms, equipment, training, and even the organization's name have all transformed. But the commitment to the essential mission set forth by the law establishing the Northwest Territory Militia has not – it is the defense and protection of our communities, state, and nation.

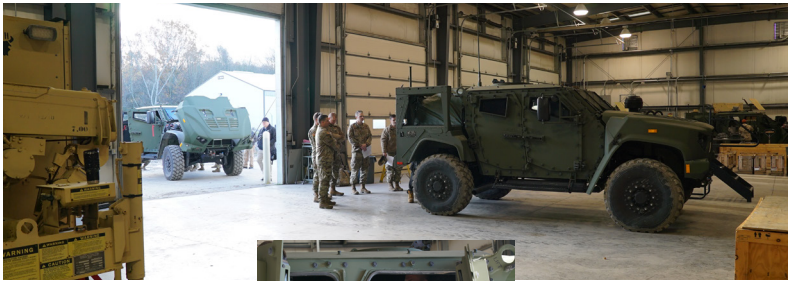

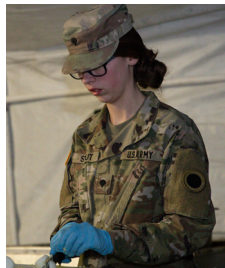

The adjutant general is responsible for oversight and administration of the organized militia of the state of Ohio and serves simultaneously as the commander of the organized militia and the Ohio National Guard; is the senior military advisor to the governor; and a member of the governor's cabinet.

To aid the adjutant general in the execution of those responsibilities, the department employs a diverse workforce reflective of its dual status as a federal and state agency. In addition to full-time federal civilians and military members, about 300 State of Ohio civilian employees contribute critical support, skill sets, and experience to several offices and divisions within the Adjutant General's Department.

They work in areas including construction and facilities management, maintenance, environmental science, geospatial information systems, information technology and web services, administrative/clerical support, accounting, government affairs and liaison, public relations and communications, lodging and hospitality, firefighting, purchasing and contracting, and human resources. The department's state employees are integral to both the success of steady-state, day-to-day operations and the overall mission readiness of the Ohio National Guard.



## STATE EMPLOYEE OF YEAR

Tim Morgan, an environmental supervisor for the Ohio National Guard, was the Ohio Adjutant General's Department 2023 State Employee of the Year. Morgan has been in the position for nearly 25 years and has been an integral part of the Camp James A. Garfield Joint Military Training Center team, assisting with the sustainable growth, development, and environmental stewardship at the installation.

## ENERGY & ENVIRONMENTAL

Leading department initiatives to continue reduction of energy consumption and harmful emissions; increase use of renewable and alternate energy sources; conserve natural resources; ensure environmental laws and regulatory guidance are adhered to by Guard units using state-operated training centers and installations.

## STATE HUMAN RESOURCES DIVISION

Manages employee pay and benefits, job announcements and new hires, career development, and performance evaluations.

## MAINTENANCE

State maintenance repair workers conduct preventative, routine care and as-needed repairs at more than 50 facilities (armories, readiness centers, other buildings) at over 40 different locations throughout the state.

## PLANS & PLANNING

Inspects, plans, estimates, and programs money for construction and renovation projects for all Ohio Army National Guard facilities; responsible for purchase of supplies and services (including mowing, trash pickup, security guards); processes ARNG recruiting storefront leases; contracts all design and construction projects.



## FIREFIGHTERS

All four Ohio Air National Guard wings (and the civilian airports they are collocated with) are supported by base fire stations manned by full-time State of Ohio fire-fighters capable of providing crash, rescue, fire, and emergency services. Mutual aid agreements with surrounding municipalities allow for increased support at the base, if needed, and make base fire department resources and manpower available to nearby communities.

## DIRECTORATE OF INSTALLATION MANAGEMENT AND RESOURCES

Oversight of several subordinate divisions responsible for all aspects of state-owned and -operated property and transaction processes including existing facilities, new capital projects, finance and budgeting, procurement and contracting, energy and environment, geospatial systems, business services, and electronic security systems.

## FACILITIES MANAGEMENT

Upkeep of existing armories, readiness centers, and other state-owned buildings, including plumbing, electrical, HVAC systems, and general infrastructure maintenance (including foundation, roofing, and painting).



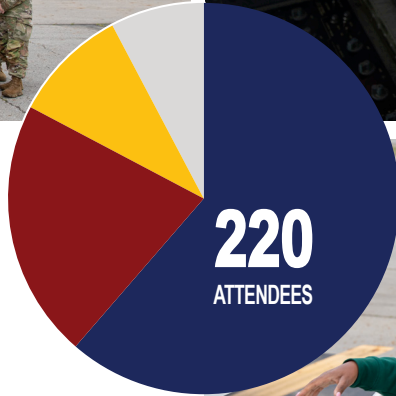
## CAMP PERRY LODGING & CONFERENCE CENTER

On the shores of Lake Erie, near Port Clinton, Ohio, staff maintains and operates a variety of modern short-term accommodations and meeting/reception areas available for rental to current/former military personnel and the general public.

## GOVERNMENT AFFAIRS

The Government Affairs Office is responsible directly to the adjutant general to engage all levels of government and with key stakeholders. The office serves as the Adjutant General's Department/ Ohio National Guard proponent for addressing elected officials and tracking constituent inquiries, managing political communications, and developing policies that enhance the capabilities and capacity of the organization. Through synchronized communications, interactions, engagements, outreach, and dialogue with state/federal officials/ legislators and other stakeholders, the Government Affairs Office shapes awareness and perceptions of the Ohio National Guard and State Defense Force while advocating for legislation (appropriations) beneficial to infrastructure, force structure, equipment, and resources.

This includes testifying before the Controlling Board, a bipartisan committee of the Ohio General Assembly that provides legislative oversight over certain capital and operating expenditures by state agencies and has approval authority over various other state fiscal activities. The board approved funding for several Ohio National Guard facilities in SFY24. (Detailed in appendices- page49)

## ONLINE PRESENCE

The Ohio National Guard utilizes five major social media platforms and email for outreach and education. A robust website keeps the public, as well as our Soldiers and Airmen, updated on Ohio National Guard activities.

# ADJUTANT GENERAL'S DEPARTMENT / THE OHIO NATIONAL GUARD **JOINT FORCE HEADQUARTERS**

The Ohio National Guard is organized under a joint Army and Air National Guard structure with the Adjutant General of Ohio commanding. In support of the adjutant general, the Joint Force Headquarters provides executive-level command and control of the Ohio National Guard through a fully-integrated joint staff and the headquarters elements for the Ohio Army National Guard, Ohio Air National Guard, and State Defense Force. It provides administrative, human resources, operations, logistics, communications, legal, fiscal, and public affairs support to the entire Ohio National Guard to include other programs and services related to wellness, Military Families, education, and facilities.

The Joint Force Headquarters serves as the proponent to develop and implement policy and regulations and to maintain readiness (managing the availability of personnel, resources, and assets required to respond to national- and state-level missions). It coordinates military support at the request of the governor in the event of a disaster or state emergency, as well as homeland defense, defense support of civil authorities, and other domestic emergency missions within the United States. The Joint Force Headquarters also serves as a liaison with National Guard Bureau, the Secretaries of the Army and Air Force, and the Department of Defense to provide ready units and Guard members to support the National Defense Strategy and contingency operations worldwide.

## **JOINT CAPABILITIES AND TRAINING**

The Ohio National Guard has several unique assets in its force to help fulfill missions in support of homeland defense and homeland security, domestic operations, and aid to civil authorities during natural or man-made disasters. Being ready to accomplish those missions requires consistent training to maintain proficiency as well as developing working relationships with local, state, and federal agency partners.



## **HOMELAND RESPONSE FORCE (HRF)**

The HRF specializes in casualty search and extraction, emergency medical triage and treatment, security, and mass casualty contamination in support of unified multiagency incident command during a state or national emergency. Regular external evaluations, like the one conducted in July 2023 at Camp James A. Garfield Joint Military Training Center, maintain the HRF's accreditations and affirm its collective capability to perform these critical missions.

## CYBERSECURITY INITIATIVES

As part of its homeland defense mission, the Adjutant General's Department is leading a number of efforts in Ohio to protect state and local government, critical infrastructure, businesses, and private citizens from cyber threats and attacks.

### OHIO CYBER RANGE (OCR)

The Ohio Cyber Range is a secure virtual environment used for cybersecurity training and technology development. OCR is accessible for competitions, training, and as a testing environment for schools, governments, and businesses. Range sites are located at the University of Cincinnati and the University of Akron.

### OHIO CYBER COLLABORATION COMMITTEE (OC3)

At the direction of the governor, the Adjutant General's Department has brought together more than 200 representatives from public, private, military, and educational organizations to form the OC3. Its mission is to provide an environment for collaboration between the key stakeholders to strengthen cybersecurity for all in the State of Ohio and to develop a stronger cybersecurity infrastructure.



### 52ND CIVIL SUPPORT TEAM (CST)

The CST specializes in identifying Chemical, Biological, Radiological, Nuclear, and high-yield Explosive agents/substances, assessing current and projected consequences, advising on response measures, and assisting with appropriate requests for state and federal support. During Operation White Powder Drill in October 2023, the CST partnered with the City of Columbus Division of Fire, FBI, and Ohio Department of Health for a multiagency training exercise.



## STATE PARTNERSHIP PROGRAM

The State Partnership Program (SPP) began as part of the European Reassurance Initiative in the 1990s. The program's intent was to partner with former Warsaw Pact/Soviet-influenced nations in Eastern Europe as a stability initiative. The SPP links U.S. states with a partner country to improve bilateral relations. The program's goals reflect an evolving international affairs mission for the National Guard, to promote regional stability and civil-military relationships in support of U.S. policy objectives.

The Ohio National Guard has two state partners. Since 1993, the Ohio National Guard has partnered with Hungary and celebrated the 30th anniversary of that partnership in 2023. In September 2006, the Ohio National Guard began a partnership with the Republic of Serbia.

The state partners actively participate in a host of security cooperation activities ranging from bilateral familiarization and training events to exercises, fellowship-style internships, and civic leader visits. Key areas of engagement include cybersecurity; chaplain training; nonlethal peacekeeping focus training and exercises; intelligence training; chemical, biological, radiological, and nuclear (CBRN) training; disaster preparedness response training; senior leader collaborations; military professional development; and aviation planning/support training. All activities are coordinated through the theater combatant commanders, the respective U.S. ambassadors' country teams and other agencies as appropriate, to ensure that National Guard support is tailored to meet both U.S. and country objectives.

# THE OHIO NATIONAL GUARD MEMBER SUPPORT

In 2023, the Adjutant General's Department realigned all behavioral health and supporting programs under the Joint Staff (J9-Resiliency) to execute a single strategy using the DoD's integrated primary prevention methodology to strengthen and promote resiliency and readiness among our uniformed members. Though this has fundamentally changed the organization's perspective on key aspects of mental health, the J9 continues a longstanding partnership with the Ohio Department of Mental Health & Addiction Services and the Ohio Department of Veterans Services to host OhioCares.Ohio.gov where service members can connect with behavioral health services. Additionally, the J9 is intent on using data and information to identify activities and actions that prevent harmful behaviors while responding to crises and building resilience among our uniformed members.



## PREVENTION

The cornerstone of prevention is strengthening protective factors that reduce negative behaviors or outcomes while simultaneously minimizing risk factors that increase the likelihood of violence or negative outcomes. The four focus areas are: sexual violence, self-harm, workplace violence, and family violence. The J9 employs 10 full-time integrated primary prevention officers to understand the risk factors impacting our uniformed members and how to increase protective factors. These professionals work to implement prevention strategies and techniques across the organization. In 2024, the program conducted a Defense Organizational Climate Survey to understand where to focus resources and effort. A significant area of concentration is the universal protective factor of connectedness taught in the First Line Leader Course, a training critical professional development course for junior leaders.

## RESPONSE

If prevention does not stop harmful behaviors, a plan to respond to uniformed members in crisis or seeking help is essential. OHIOcares provides 24/7 assistance to uniformed members enabling assistance in real-time for mental health concerns. Recognizing harmful behaviors is a focus for command briefings and workshops for all uniformed and non-uniformed members of the organization. These instructional periods are reinforced by more intense leader-focused trainings like the Ask Care Escort (ACE) suicide intervention training that enhances members' skills in recognizing suicidal ideations and understanding how to respond effectively.

## RESILIENCE

The ability of uniformed members to rebound from stress before it leads to harmful behaviors is a foundation of prevention at the individual level. Resilience training occurs at the individual and group level through Army and Air Force curriculums. The skills taught in these programs are combined with health and wellness initiatives that deliver a holistic approach to resilience. A uniformed member who is mentally and physically healthy is more resilient to stress. The J9 continues to determine the most effective programs to meet the needs of the force through data collection and collaboration with other professionals.



## WELLNESS PROGRAMS

**SOLDIER AND FAMILY READINESS SPECIALISTS** track requests and work cases (including those Soldiers participating in Operation Solid Start), to provide resource support to Military Families within four Ohio regions.

**OPERATION SOLID START PROGRAM** offers a holistic understanding of Soldier readiness at the individual level to create stability at home and within a unit, thus allowing Soldiers to meet individual and collective training requirements in preparation of state and federal mobilization and missions.

**BEHAVIORAL HEALTH** is a team of seven civilian psychological health coordinators who advise Army leadership, members, and their Families with acute behavioral health needs.

**SURVIVOR OUTREACH SERVICES** provides long-term case management for Families of the fallen as part of the Army Casualty Continuum of Care.

**CASUALTY ASSISTANCE** is available to next of kin members receiving benefits and/or entitlements in death or missing cases, who need ongoing exchanges of information with the Department of the Army.

**SEXUAL ASSAULT PREVENTION & RESPONSE** program provides tools and resources to prevent the occurrence of sexual assaults while also protecting the rights and dignity of victims.



## CAREER/FINANCE PROGRAMS

**NATIONAL GUARD EMPLOYMENT ENHANCEMENT PROGRAM** provides support to connect employers and businesses seeking to hire veterans and service members. They assist clients with resume, job search, networking, and placement.

**PERSONAL FINANCIAL COUNSELORS** help Ohio Soldiers, Airmen, and Family members manage finances, resolve financial problems, and reach long-term goals such as getting an education, buying a home, and planning for retirement.

**TRANSITION ASSISTANCE ADVISORS** play a significant role in retirement programming, providing individualized and group consults on benefits, resources, programs, and services to Soldiers who are retiring or separating from the Ohio National Guard.



## FAMILY PROGRAMS

**STATE CHAPLAIN'S OFFICE** offers several online learning opportunities for Soldiers and Family Members to develop relationship and financial skills in addition to traditional in-person Family, couples, and singles Strong Bonds Program weekends.

**YOUTH PROGRAMS** are provided for school-aged military-connected youth ages 6-18. Over 4,000 Ohio Military youth and Family members are impacted annually through family retreats, single-day activities, and summer camps.

## PARTNER PROGRAMS

**INTER-SERVICE FAMILY ASSISTANCE COMMITTEE (ISFAC)** is a state-level committee of regional, state, and federal agencies and organizations that meet to collaborate and align resources in support of Ohio troops and Military Families.

**EMPLOYER SUPPORT OF THE GUARD AND RESERVE** promotes cooperation and understanding between Reserve Component members and their civilian employers, and assists in the resolution of conflicts arising from an employee's military commitment.

**YELLOW RIBBON REINTEGRATION PROGRAMMING** assists Guard members and their Families with the rigors of deployment and reintegration into civilian life through briefings and online events.

**MILITARY ONESOURCE CONSULTANT** builds relationships with organizations and individuals that provide support to service members and their Families.

# OHIO AIR NATIONAL GUARD 179TH CYBERSPACE WING



The 179th Cyberspace Wing, located at Mansfield Lahm Air National Guard Base in Mansfield, Ohio, has been selected to be the nation's first Air National Guard cyberspace wing. The 179th's primary mission for the previous nearly 50 years was military cargo airlift, until the divestiture of its C-130 aircraft in the summer of 2022 in conjunction with its conversion to a cyberspace wing. The unit transformation will challenge and shape its capabilities and Airmen as it evolves to meet its new tasking. The organizational focus will be to take care of Airmen — through training, equipping, and leading — to meet the unit's Initial Operating Capability requirement in 2025 and Full Operational Capability in 2027. The 179th CW's infrastructure will be transformed to support secure communications facilities, additional power needs, and other requirements. The new mission will provide cyber-enabled capabilities supporting tactical needs in air superiority and information warfare, which will provide a competitive advantage in combat performance, and survivability in joint force operations.

The unit provides administrative and other support to the 200th RED HORSE (Rapid Engineer Deployable Heavy Operational Repair Squadron Engineers) in Port Clinton, Ohio.

# OHIO AIR NATIONAL GUARD 180TH FIGHTER WING



## PROVIDE FOR AMERICA

The 180th Fighter Wing, located at Toledo Air National Guard Base in Swanton, Ohio, operates the F-16 Fighting Falcon jet aircraft. The 180th FW trains, organizes, and equips expeditionary war fighters to deploy, fight, and win worldwide, with minimum response time, in cases of national emergency or war. The 180th FW provides for America; protection of the homeland, effective combat power, and defense support to civil authorities. The 180th FW has access to multiple military operating airspaces and air-to-ground gunnery ranges perfectly suited for the capabilities of the F-16. Centrally located with access to three major military operations area (MOA) airspace complexes, the 180th FW regularly uses the Buckeye and Brush Creek MOA airspaces in southern Ohio, the Alpena MOA airspace complex in northern Michigan, and the Indiana Air Range Complex MOA in southeast Indiana. To stay ready and razor sharp in the execution of its 24/7 aerospace control alert mission, the 180th FW conducts monthly training exercises in the surrounding national airspace regions to enhance command and control, and air traffic control integration with fighter escort for its alert intercept mission.

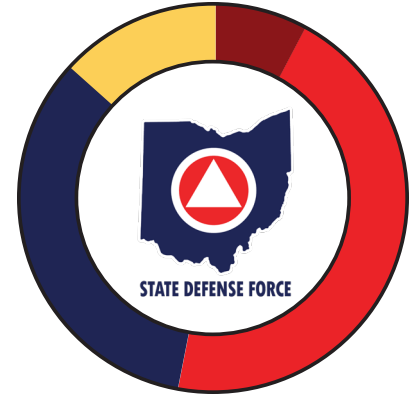
# STATE DEFENSE FORCE

## TOTAL AUTHORIZED STRENGTH

The State Defense Force (SDF) comprises the Ohio Military Reserve, Ohio Naval Militia, and the Ohio Cyber Reserve.

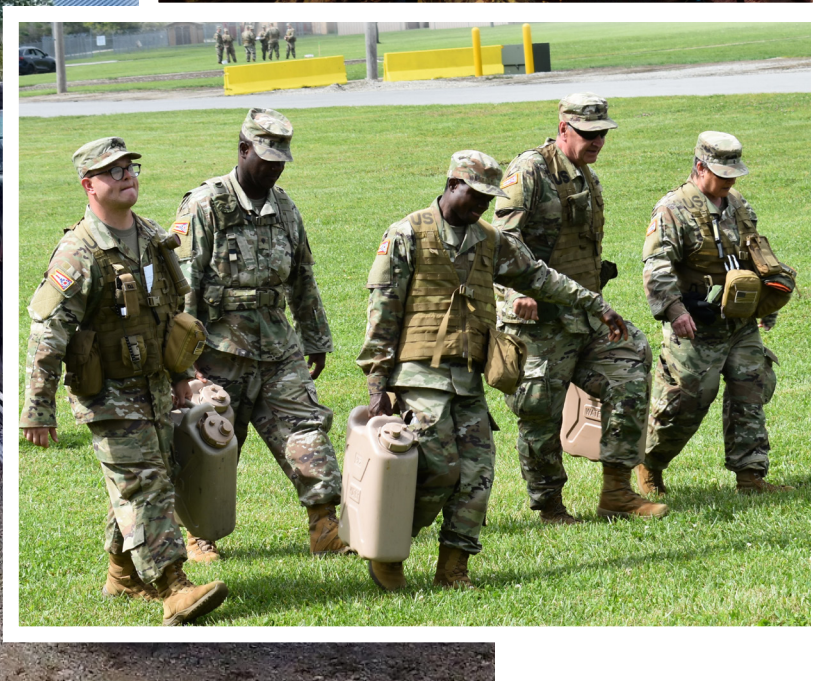
As integral parts of the Adjutant General's Department, these organizations have specific roles that enhance the capabilities of the Ohio National Guard and provide additional civil-military expertise and functionality. The SDF has an exclusive focus on protecting the state. Elements of the SDF share similarities, with regard to rank and organization (Ohio Military Reserve and U.S. Army; Ohio Naval Militia and U.S. Navy), but are not part of the federally funded Reserve Components, like the Army and Air National Guard.

## SDF HEADQUARTERS 31

The State Defense Force (SDF) is commanded by a brigadier general (non-federally recognized) who reports directly to the adjutant general and maintains a staff of about 30 personnel.







## CYBER RESERVE 135

Organized in 2020, the Ohio Cyber Reserve (OhCR) comprises civilian cyber professionals from academia and private/public enterprise.

These volunteers form regional OhCR teams that are available for the governor to assist eligible municipalities, state agencies, and other governmental entities with cybersecurity vulnerabilities and provide recommendations to reduce cyber threats. OhCR volunteers provide workforce development to train the cyber talent of the future and assist STEM teachers by providing mentors for high school cyber clubs. OhCR members are true volunteers; they are not compensated for their training or service, unless activated by the governor to perform state active duty.

The OhCR is one of only a few cyber preparedness and response elements nationwide, established at the state level under an organized militia. The passage of Ohio House Bill 52 in October 2019 authorized the establishment of the OhCR under the SDF and Adjutant General's Department.

## MILITARY RESERVE 183

Established in 1949, the Ohio Military Reserve (OHMR) is a key part of the Adjutant General's Department.

The OHMR is focused on providing capabilities related to Emergency Support Functions 6 (Mass Care) and 7 (Logistics and Resource Management) under the Federal Emergency Management Agency (FEMA) Incident Command structure. The OHMR also recently gained drone/remotely piloted aircraft capabilities to support its assigned state missions. Organized similar to an Army brigade, the OHMR has the requisite training, administrative, operational, and sustainment capacity to respond to state-level emergencies.

OHMR members are not compensated for their training except during state active duty missions and paid according to their pay grade/rank.

## NAVAL MILITIA 54

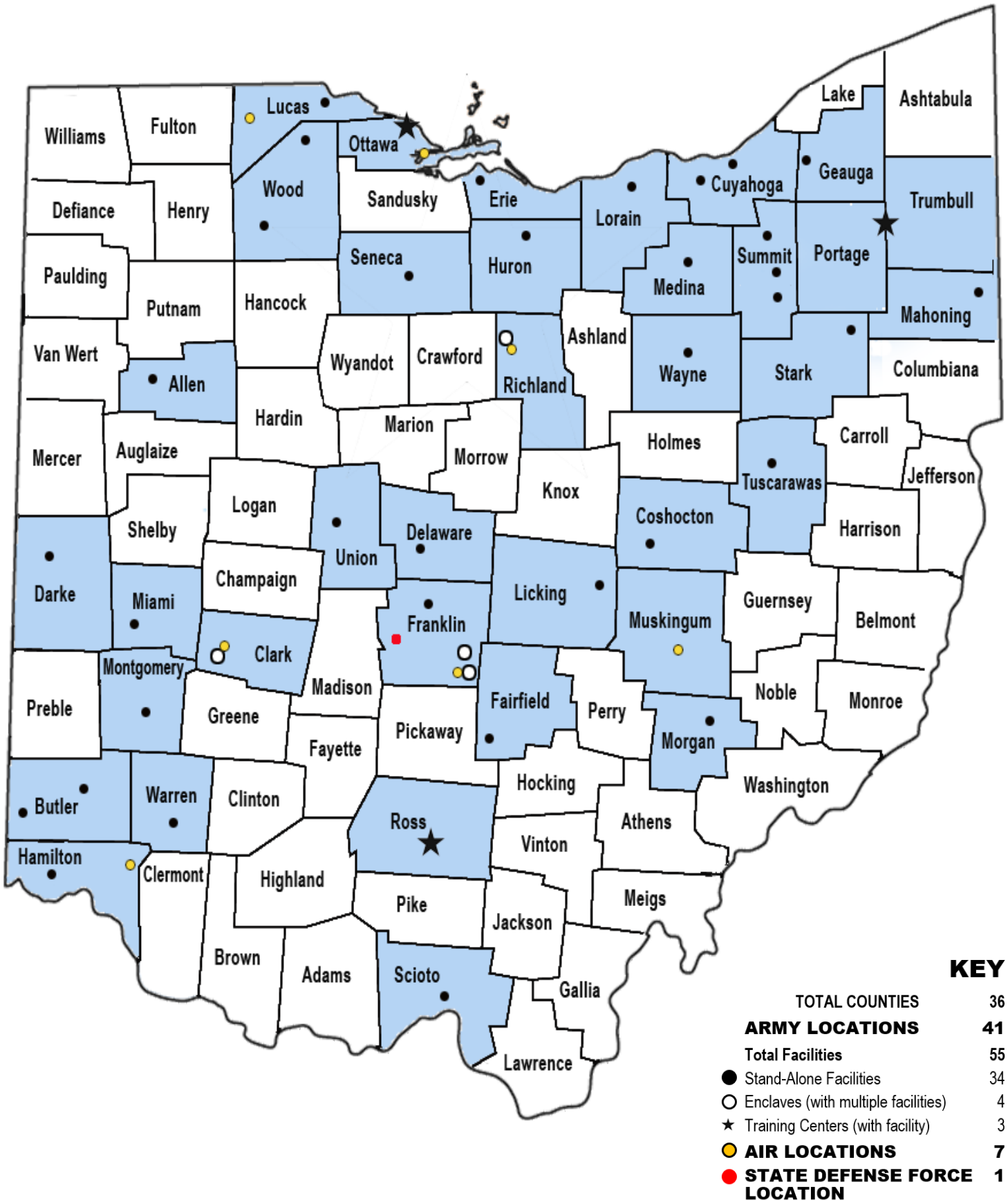
The Ohio Naval Militia (OHNM) is an organized, all-volunteer unit that has been serving the state of Ohio since 1896.

The OHNM's primary mission is to provide safety and site security support to the weapons ranges at Camp Perry Joint Training Center, just outside Port Clinton, Ohio, on the shores Lake Erie. Like other SDF components, members of the OHNM are not compensated for their training or service unless performing state active duty missions. OHNM members conduct extensive monthly training, includes GPS, radar, radio communications, CPR/AED, and first responder first aid. Members who are certified through the Ohio Department of Natural Resources volunteer their time to conduct the Ohio Boater Education Course.
